Note:

This watercolour is thought to have been acquired by Hildebrand Gurlitt in the 1940s in France, possibly through the art dealer Raphaël Gerard. Gurlitt acquired one other Boudin work through Gerard, that work being *Rade de Bordeaux* (Lostart-ID 532949).

Gerard is known to have mounted a Boudin retrospective in 1937. Among the exhibited works were five watercolours generically described as beach scenes. Owing to a lack of more specific details, those sheets could not be identified.

The personal papers found in Cornelius Gurlitt's Salzburg home include a collection of about 2,400 photographs of artworks. Photograph no. 9.2_F9288 is a reproduction of a drawing not found in the Schwabing Art Trove; on verso, a reference to this Boudin work.
