The art collection of MARGRET KAINER looted by the National Socialists

Here: Information for possessors, possible buyers, sellers. auction houses and dealers regarding such works of art for which restitution agreements have been concluded in the past;

Restitution agreements concluded with third parties, and in particular with a Swiss foundation or a Swiss administrator of the estate, regarding works of art that once belonged to the collection of MARGRET KAINER, do not change the fact that these are looted artworks.

For further clarification of facts and the legal situation, please contact the representatives of MARGRET KAINERS's heirs (Mondex Corporation)

Dear Ladies and Gentlemen,

Mondex Corporation, located in Toronto, Canada, hereby gives notice that it has been retained by the heirs of MARGRET KAINER (hereinafter "MARGRET") to locate works of art, which were misappropriated from MARGRET by the Nazis.

MARGRET was the daughter of the well-known Jewish entrepreneur NORBERT LEVY (hereinafter "NORBERT), who lived in Berlin. NORBERT died in 1927 as a widower and MARGRET became his sole heiress. In addition to real estate, shares, company participations, MARGRET also inherited a valuable art collection from her father.

These assets were unjustly taken from MARGRET by the National Socialists. Her art collection was auctioned off by the "Union Leo Spik" auction house, based in Berlin, on May 31, 1935. The six paintings, by DEGAS, LEIBL, MONET, PISSARO and RENOIR, are listed to the right of this letter, and were

After the end of the Second World War, MARGRET conducted several restitution proceedings regarding the property unjustly taken by the National Socialists. When MARGRET died in Paris on December 18, 1968, the proceedings concerning the art collection, misappropriated from her by the National Socialists in particular, had not yet been completed.

MARGRET as well as her husband LUDWIG, who had already died in 1967, had their residence or habitual abode in Paris until they died. MARGRET and LUDWIG were also registered with the police in Switzerland after the Second World War, although they lived in Paris. This was necessary because it was the only way they could get the refugee passports issued to them by the Swiss authorities, extended.

MARGRET had also invested a considerable part of her assets with a Swiss bank (hereinafter the "SWISS BANK"), whose employees she obviously placed special trust in. Her father NORBERT had also entrusted directors from the SWISS BANK with managing a family foundation he had arranged prior to his death to support members of his family.

When MARGRET died, childless, in Paris on December 18, 1968, she did not leave a will. Although numerous members of her family had been murdered by the National Socialists (Nazis), others were able to escape from the National Socialists. However, they lived, scattered in numerous countries around the world as a consequence of the Holocaust.

This tragic situation was exploited by employees of the SWISS BANK. One of the employees who had allegedly managed MARGRET's equity investments account was appointed as administrator of MARGRET's estate and joined the restitution proceedings pending in Berlin. A director of the SWISS BANK claimed that as a member of the board of trustees he represented the family foundation established by MARGRET's father - although this foundation was already supposed to have ceased to exist. The director of the SWISS BANK named the foundation he represented after Margret's father the "Norbert Levy Foundation" and later as the "Norbert Stiftung" (hereinafter referred to as the "SHAM FOUNDATION") This SHAM FOUNDATION took part in the proceedings and, in 1972, it succeeded in obtaining both the payment of high compensation sums as "restitutions" but also a partial certificate of inheritance, after the ADMINISTRATOR OF THE ESTATE had falsely indicated to the Court that MARGRET had no surviving family members and therefore no heirs.

In 2012, the French authorities determined in a certificate of inheritance procedure that MARGRET had not had her last residence in Switzerland but in France, and that several of her cousins, were her heirs, who were very much alive when Margret passed away. As a result, in 2016, the German authorities formally revoked the partial certificate of inheritance that had been issued to the SHAM FOUNDATION in 1972. It was declared invalid and void (as per the Orders of the Charlottenburg District Court dated 29.01.2016 and 09.05.2016 in both cases regarding the file number 64/6 VI 1467/1928).

However, between 1972 and 2016, the SHAM FOUNDATION and the ADMINISTRATOR OF THE ESTATE had unconscionably represented to possessors of looted art that they were co-heirs of MARGRET. They had successfully entered into restitution agreements in connection with the six works of art listed alongside.

These restitution agreements could not and cannot have any legal or moral effect vis-à-vis the members of MARGRET's family, who are her only rightful heirs.

Thus, the works listed here are still "looted art".

The following paintings are therefore still deemed as "looted art":

- Camille Pissarro: "Lavoir et Moulin d'Osny", Oil on canvas, 65,30 x 54,30 cm, Signed bottom left: "Pissarro 84";
- Auguste Renoir, "Bouquet de Fleurs", Oil on canvas, 40 x 51 cm, Signed bottom left: "Renoir";
- ➤ Auguste Renoir, "Jeune fille à la toque", Oil on canvas, 32,50 x 27,50 cm, Signed top left: "Renoir".

It is not known whether the SHAM FOUNDATION and/or the SWISS ADMINISTRATOR OF THE ESTATE have entered into corresponding restitution agreements with additional possessors of "looted art" from MARGRETS former art collection. Should this be the case, the foregoing shall apply accordingly.


